15. Approval of Minutes from Smisby Parish Council Meeting held on 8th March 2022

Resolved, all Councillors approved and the Chairman signed the minutes.

16. Parochial Charity Communications

A newsletter is going to be introduced twice a year, contributions to the Council newsletter will continue. The PCC have agreed to fully fund the parish jubilee party, they need receipts to be submitted to them. The jubilee gift will be two whisky glasses engraved with the official jubilee crest in a presentation box. 125 sets have been ordered and will be distributed to households in the Parish. Field tenancy is with their solicitor. Grounds maintenance quotes are needed for their due diligence. Chair advised that the Council had gone with the cheapest quotes.

Jubilee Celebrations

Some detailed are covered under Chairmans report. WI will help with decoration and the Parochial Charity with funding. The Church has advised that they are happy if the railings are decorated, but nothing with the Queens head can be displayed on the church grounds.

18. Parish Field

PCC have advised the contract is still with their solicitor. The idea of developing the petanque pitch to something different as suggested by a member of the community should be a more overarching idea and the Council need to discuss further. All agreed that a joint working group is needed, it will be put into the next newsletter asking for a volunteer to run it.

19. Insurance

Resolved, all agreed for BHIB for a 3-year deal.

Drains, Flooding and Highways

A number of drains have been marked up on Forties Lane, the plan is to put a skirt around them to stop filling up with debris. Councillor Taft is to attend the Flooding Forum on Friday. DCC have come back saying they can allow the parish council to extend the pavement, but have not answered if they will waive their costs. Inspections and traffic management would incur extra costs, and a 'PCC' between the wall and pavement. Discussion was had if the

Parish Council should be paying for work and who would maintain afterwards. Councillor Taft is to continue dialogue with DCC Highways.

21. Smisby Lockup

Work not started yet, Clerk to chase the work and inform the grant provider of the delay.

22. Community Speed Watch

Ongoing speed watch activities are taking place and statistics remain very steady. 300 letters have gone out and 4500 cars surveyed. There is ongoing communication with CREST about where they are surveying, Councillor Cuming is to chase this up with them. SIDS, the Police and Crime Commissioner has agreed for temporary trial, Councillor Cuming has started the application process and County Councillor Muller has agreed to approve it. Councillor Cuming is to attend an event at Melbourne tomorrow on this subject he suggests that two are applied for, one each way as you are not meant to move the equipment due to being on a public highway. He advised that the Council need to look at finances and what happens after the 12-month trial.

Ukrainian crisis, as a County have put a lot of money into it, and people are coming into the area. Levelling up is being talked about and joining counties together for their County and City Councils. The energy crisis is causing a lot of concern. Chair advised that the level of complaints is rising on plane noise from the airport
