16. Parochial Charity Communications

Robert Hounslow asked if the Council were now happy with the draft lease for the parish field. Councillor Brooke advised that he was happy with the draft, on behalf of the Council. **Action the Clerk to advise the Parochial Charity.** The Parochial Charity are having some work done on the parish field to deal with the moles and repair the football pitch. He thanked the Parish Council for the work on the telephone box. He also encouraged any application to them for funding for ideas that would enhance the Parish.

17. Parish Field

- a. Signage for the field was discussed around noise and anti-social behaviour. The Parochial Charity advised that if the Council let them know the costs, they may be able to reimburse these.
- The Lengthsman was thanked for their continued work on ensuring the Field is kept clear of litter, along with Councillors Cuming and Brooke who had assisted in a general tidy up.

20. Parking

There is a band of land next to where the hedge has been taken down on Chapel Street, which could potentially be used for parking. District Councillor Churchill advised that it doesn't look like this is owned by the adjacent house holder, he checked this on www.maps.derbyshire.gov.uk. Councillor Brooke advised that he would check with the Land Registry.

21. Communication

Two emails had been received by the Clerk from parishioners advising that they did not want the newsletter to be virtual only. The virtual newsletter is on trial for this financial year. A copy will be available in the telephone box at the Village Hall.

22. Drains and Flooding

Councillor Taft reported no current issues, drains are being inspected and actively cleaned. Repairs and improvement to drainage is being scheduled by DCC and other agencies.

23. Community Speed Watch

No change, on hold due to current COVID-19 guidelines.

24. Poplars Pavement

Councillor Cuming had chased the outstanding work at the Poplars wall and pavement.

Smisby Parish Council had submitted a comment on the planning application DMPA/2021/0333, asking if it was possible for signage to be installing for any vehicles going to Kilworth Machinery to not go through the Village. The Clerk had submitted this comment to SDDC before the closing date.

District Councillor Churchill advised that there would now be two Flood Liaison Meetings per year, they did discuss run off from roads and advised it may be useful for Smisby Parish Councillors to attend. He will pass the details of the next meeting over to the Clerk. Freeport are putting in their governance structure, he will keep the Council informed of any further information he receives
- District Councillor Haines advised that South Derbyshire were below average in the Covid infection statistics. The Covid Wardens are still operating in Swadlincote town centre.
