#### Commemorative Bench



Smisby Village was delighted to see a new commemorative oak bench installed on the corner of the Forties Lane and Chapel Street junction under the historic Beech tree. The beautiful bespoke bench was very generously and personally commissioned by local

resident, Peggy Moore, to recognise the 100 year anniversary since the 1st World War and the lives lost from Smisby.

The collaborative project saw the Parish Council seek the relevant permissions from the local authority and the Parochial Charity fund the installation, all in time for the Remembrance Service Armistice Day weekend in November.

If you have chance you should take in the wonderful vista from the bench itself looking across to the War Memorial and St James's Church.

# Proposed Relocation of Smisby Telephone Box



There has been much discussion over the current condition and location of the Red Telephone Box on Chapel Street. Members of Smisby Parish Council would like to propose the full refurbishment and relocation of the Red Telephone Box from Chapel Street to within the grounds of Smisby Village Hall on Main Street.

The Telephone Box would be mounted within the grounds just inside the gate adjacent to the village hall and would be maintained in perpetuity by the Smisby Parish Council. This would then be visible for all residents and visitors to Smisby as you come into the village. Following its de-commission we have been exploring different projects for its usage which have been undertaken by other villages. It was something residents saw as an iconic feature and it was something we didn't want to lose. We want to go down the route of a complete refurbishment and turning it into something else. Some communities have transformed red phone boxes to host a community village Library and would act as a Book Exchange by holding donated books for residents of all ages.

The Smisby Parish Council, a locally elected body to represent the views of the residents, wholly supports the proposal of relocating the refurbished Telephone Box to within the grounds of Smisby Village Hall but has decided to conduct a full referendum for consideration by Smisby Parish residents to agree the way forward and to allow democracy to decide.


# Chapel Street Parking It has been brought to our attention that vehicles

It has been brought to our attention that vehicles are parking in and around the entrance to the Jubilee Grounds playing fields off Chapel Street, Smisby. Any unauthorised parking in this area poses a safety risk to pedestrians using the playing fields and is also a potential blockage for emergency access as well as general access for residents turning onto Chapel Street.

There should be no parking in front of this



entrance. A SDDC No Parking sign will shortly be installed and visible on the telegraph pole enforcing this. Thank you in anticipation of your cooperation.



#### **Smisby Parish Council Vacancies**

Smisby Parish Council represents the needs and concerns of all age groups within the community and is a tier of local government. As we approach the forthcoming May AGM, the Parish Council is facing a situation where the number of councillors is very fragile. In order to maintain the minimum governance requirements to operate as an effective council we need to fill at least three vacancies. We could potentially lose control to the District Council as the first point of influence on local matters that directly affect Smisby residents if we are unable to fill these posts.

The same scenario occurred back in 2011 when faced with the same potential outcome; the current crop of serving councillors then stepped forward to volunteer and serve their community when needed most, and protect local matters important to village.

We would like to fill these 3 vacancies by co-option at our AGM on 14th May.

The Parish Council meets alternate months on a Tuesday night at 7.30pm in the Village Hall. Meetings are generally no more than a couple of hours at the most. The voluntary post only takes up a modest amount of time but the time you give would be invaluable to the Community and can make all the difference. It is incredibly important we retain a control in Local Governance on all matters arising that affect the Village and our influence as a serving Parish Council should not be underestimated. We are particularly interested in potential candidates who are not already serving in role on another committee within the village.

### **Parochial Charity**

I thought it would be appropiate in the first newsletter of 2019, to remind everyone how 'The Parochial Charity in the Ancient Parish of Smisby' actually functions.

The Charity was set up in 1794 and is required to distribute its income, but to maintain its endowed capital in perpetuity. The value of the holding has grown over the years to its current value of £2.64M, which is a huge sum of money and carries with it a great responsibility. The Charity is run in accordance to a 'Scheme of Arrangement', which is its governing document. This states how we are to run the Charity, how the capital must remain intact and that we are only able to spend the income. Consequently, it is managed by 4 Trustees and assisted with part-time paid administrative support. The investment of this money requires specialist advice, which is provided by an investment company. For an agreed annual fee, they provide us with investment advice and we hold regular meetings with the company to discuss our options. For any land purchase that the Charity may make, we use a local land agent.

The charity is required to give half of its income (after deduction of expenses) to the Church Charity, for the benefit of St James' Church. This sharing rule dates back to when the Charity was set up in 1794. The other half is used for the benefit of the local Parish and resident Parishioners. There are many examples of these benefits:

- Providing an annual grant towards tertiary education, usually for university accommodation for students normally resident in the Parish
- Providing book tokens at Christmas for all schoolchildren between the ages of 2 and 16
- An annual grant to the Smisby Women's Institute to subsidise educational visits for the members (which has previously included a tour of the Houses of Parliament)
- Funding the Christmas Party held in the Smisby Village Hall
- Providing a Christmas Hamper for all Parishioners who have reached 60 (for ladies) and 65 (for gentlemen)
- Ad hoc funding of individual cases of hardship submitted by Parishioners
- Providing money for projects in the Village e.g. refurbishment of the Village Green; updating facilities of the Village Hall – air conditioning; 50% of the audio/visual project
- Provision of funding for specialist events eg the party to celebrate 1000 years of existence of the village of Smisby

We always welcome ideas for funding new projects, particularly those that can benefit large numbers of residents, so please keep the ideas coming and help us make Smisby an even more attractive place to

#### St James' Church

There was a good attendance for the 100th WW1 Anniversary Remembrance Service and a ceramic poppy for each local villager lost in conflict was used in our decorations.

Over the Christmas period there were several well attended events, with a full house on 1st December for the musical introduction to the village Christmas party. On 6th December Smisby W.I. hosted a good congregation for the "Harpur Crewe Group" Carol service in church. 23rd December saw the Church's traditional service of lessons and carols and on Christmas Day there was a morning celebration of Communion.

In the early part of this year we have experimented with having a few 4 p.m. services in the village hall, including a delightful Christingle service at which the local "Beaver" group and the other children sang for us. No conclusions have yet been drawn on whether to continue with these services in the more informal setting of the village hall as attendance has been patchy. At the time of writing we are looking forward to our Mothering Sunday service in Church at 4.p.m. on 31st March at which there will be flowers or plants for youngsters to distribute to their Mums.

Our Annual Church meeting is scheduled for 7th April, immediately following Evening Prayer at 4.00pm, and this is also in the village hall. We also extend an invitation to everyone to our Easter Sunday service in church 9.00am 21st April. This is always a joyful and meaningful occasion in the life of the Church, and we will be surrounded by spring flowers.

Special thanks go to Hazel who gives a lot of her time and effort to creating a children's choir for our special events, and it would be wonderful to welcome more local youngsters into St James on these occasions.

#### Yuk! Chewing gum - Please don't drop your gum outside my home



#### Yuk! dog fouling - Please don't let your dog foul outside my home.

Yuk! is the Derbyshire County Council campaign against dog fouling. Help to keep our Village free of dog mess. Dog fouling is ongoing problem and nuisance within the Parish. As always, unfortunately it is the responsible dog owners who are implicated because of the actions of a very small minority within a community who fail to follow the basis etiquette of being a dog owner and clearing up after your own pet. This requires vigilance by everyone and anyone observed not bagging up dog foul should be reported to the Council. South Derbyshire's Dog Control Order makes it illegal for an owner not to pick up after their dog in all public open land in South



Derbyshire. They are also instructed to investigate all complaints about dog fouling and to act on any intelligence about possible offenders. Not only can dog mess cause stomach upsets and headaches, but also asthma and blindness. To help combat the danger you can display one of the weather-proof Yuk! signs. Pick one up from any Derbyshire library or complete the form on line and they will post a sign out to you. They can be attached to gates, fences, or displayed in a window. These signs should act as a reminder to the small amount of irresponsible dog owners to think of the health risks if they don't clear up after their pets.It is every dog owners duty to clean up after their dog. There are no excuses, fouling is unacceptable


