2. <u>Chairman</u> It was proposed by Mr. Cooper and seconded by Mr. Barnett that Ms. Hynam be Chairman of

the meeting.

3. Minutes Minutes of the previous meeting was to be signed at a later date.

4. Matters Arising

a. 'Redacted'

b. Tree Survey

Quotes had been received and it was agreed that John Booth's quote be accepted.

ACTION: Ms. Hynam to forward the quote to Neil Hogbin for the matter to be dealt with by Fisher German.

c. Jubilee Field Lease

Ms. Hynam reported that Neil Hogbin had chased James Coningsby of Nelsons but to date had still not received the amended Lease from him. It was hoped he will have received an update for when the Trustees have a meeting with him on the 27 April 2022.

d. Jubilee Field Maintenance

The Clerk reported quotes had not yet been received from the Parish Council as requested by Mr.Hounslow.

ACTION: The Clerk to request the Parish Council to forward quotes to the Charity before consideration of funding would be granted.

e. Jubilee Field Equipment Insurance

Even though the Clerk had requested a reply from the NFU this was not forthcoming to date. **ACTION**: The Clerk was requested to contact them again for a reply.

f. Land Registry

If no response was received from Browne Jacobson then this matter to be discussed at the meeting with Neil Hogbin.

g. Commemoration to Mr. J. Barnes

As it had been a while since the first quotations were obtained, Mr. Cooper had contacted the suppliers of the bench who confirmed that Accoya wood was not now supplied and that it would be oak which would result in an increase in cost from £1093 to £1448. The installation date still remains at 12-16 weeks after confirmation. Mr. Cooper had found it difficult to contact Gary Margerrison re the placing of the bench and asked if Mr. Barnett would be able to help.

ACTION: It was agreed to go ahead with the oak bench and Mr. Barnett offered to contact Gary Margerrison regarding the fixing.
