## **Business: 'Redacted Text'**

#### **Jubilee Field Lease**

Although Neil had chased James Coningsby of Nelsons to complete the Lease it had still not been received. The amendments to the Lease were the change of tenure from 10 years to 7 years and Ms. Hynam was to inform Neil of any other amendments especially the maintenance of the grounds.

**ACTION**: Neil to chase James Coningsby.

### **Jubilee Field Maintenance**

The Clerk had requested sight of all the quotes the Parish Council had obtained receiving a reply from the Clerk that permission had to be sought at their next meeting.

**ACTION**: The Clerk was to ask the Clerk of the Parish Council to get an out of committee decision as the matter had been going on for a long time.

## **Tree Survey**

It was agreed to go with the quote of 'Redacted Text' and he would let Mr. Barnett know when the survey would take place in a couple of months' time.

### **Land Registry**

A quote for updating the land registry had been received from Browne Jacobson but it was deemed that approximately £1200 per registry was incredibly high. Also considered was the decision for the Charity to investigate a Foundation CIO following a discussion with Thomson Snell & Passmore Solicitors.

**ACTION:** Ms. Hynam had already obtained lesser alternative quotes and was able to arrange a meeting to discuss this possibility and what it would entail. She was to inform the Trustees of a date and time to suit everyone accordingly.
